

**TEKTRONIX COMPONENT SOLUTIONS/PUBLIC  
U.S. GOVERNMENT FLOW DOWN TERMS AND CONDITIONS:  
FEDERAL ACQUISITION REGULATION (“FAR”) AND AGENCY FAR SUPPLEMENT CLAUSES**

The following clauses of the FAR and Agency FAR Supplements are incorporated herein by reference and made a part of this subcontract/purchase order. In all such clauses, unless the context of the clause requires otherwise, the term “Contractor” shall mean subcontractor/vendor, the term “Contract” shall mean this subcontract/purchase order, and the terms “Government,” “Contracting Officer,” and equivalent phrases shall mean Maxtek Components Corporation, dba Tektronix Component Solutions (“Tektronix”) and Tektronix’s authorized representative, respectively. It is intended that the referenced clauses shall apply to subcontractor/vendor in such manner as is necessary to reflect the position of subcontractor/vendor as a subcontractor to Tektronix, to ensure subcontractor’s/vendor’s obligations to Tektronix and to the United States Government (“Government”), and to enable Tektronix to meet its obligations under its prime contract or subcontract with a Government end customer. Those clauses which reference a time requirement will be interpreted to mean 75% of the allotted time requirement, thereby allowing Tektronix sufficient time for any review, incorporation, and/or notification to the Government. If any of the following FAR clauses do not apply to this purchase order, such clauses are considered to be self-deleting. Supplier shall incorporate into each lower tier contract issued in support of this purchase order all applicable FAR clauses in accordance with the flow down requirements specified in such clauses.
