

Tektronix Innovation Forum Sweepstakes
OFFICIAL RULES

PROMOTER The Promoter of this Promotion is Tektronix Inc., 14150 SW Karl Braun Drive, Beaverton, OR 97077 ('Promoter').

1. **HOW TO ENTER** Entrants should complete and submit the registration form for the Tektronix Innovation Forum which is located on the associated landing page, accessible via the e-mail offer. To be eligible to participate in the Sweepstakes ("Promotion"), you must be; (1) above the age of majority in the state, country or province where you reside at the time of entry; and (2) be a resident of the United States or Canada. The Promotion is void where prohibited by law. Any entries from entrants residing in a state, country or province where the Promotion is illegal or would require administrative filings to be legal will be rejected, as this Promotion is void in those locations. Additionally, residents of countries to which export, re-export or transfer of a prize is restricted by the United States or any other country law or regulation are not eligible to participate. 3. **WINNERS** Six (6) Winners will be randomly selected from all entries received during the Sweepstakes Entry Period. The Winner will be notified by phone and/or email within five business days after the drawing at the contact details provided by the entrant. Each potential Winner is subject to verification by Promoter, whose decisions are final and binding in all matters related to the promotion. An entrant is not a Winner unless and until entrant's eligibility has been verified, the entrant has returned the Affidavit and entrant has been notified that verification is complete and no further action is needed. In the event a Winner cannot be determined, that prize will not be awarded.
